What information should be provided on my product page?

Essential product information

According to article L.111-1 of the French Consumer Code, the following information must be provided on the product page:

- Essential characteristics of the good/product
- Price
- Date
- Identity, postal, phone, mail contact
- Legal guaranty
- ...

This obligation can be fulfilled, for example, by a **photography** of the product label containing this information, or by **reproducing the label** in its entirety in the description section.

Chemical product information

In addition to the above information, other information on chemicals must be provided in accordance with regulation 1272/2008 on classification, labeling and packaging of substances (CLP):

- Trade name or mixture designation
- Nominal quantity
- Wording of hazard statements (H-phrase or EUH)*.
- All sensitizing substances present in concentrations equal to or greater than those listed in table 3.4.6 of annex I of regulation n°1272/2008.
- An SDS may be available online for information (link to QuickFDS).

Biocide product information

In addition to the above information, for biocide products* other information must be present according to regulation n°528/2012 on biocides:

- Biocide Product Type (PT).
- The identity of each active substance and its concentration.
- The name of any nanomaterials contained in the product.
- Instructions for use.

*Motul does not sell biocidal products within the meaning of regulation n°528/2012.

Detergent product information

In addition to the essential information, for detergent products other. information must be present according to the detergent regulation n°648/2004:

- Product content as specified in Annex VII, Part D of the Detergents Regulation with of a detergent composition sheet (available on QuickFDS).

Specificity for a hazardous product

CAUTION, when a product with a hazard is sold online, its hazards must appear directly, **WITHOUT HAVING TO CLICK ON A LINK**.

There are two ways of doing this:

- Show the label with the hazard phrases and pictograms in the product photos.
- Transcribe the hazards and/or pictograms in the product description.
